## GENERAL INFORMATION & LICENSE FEES

### ADMISSION REQUIREMENTS

To access a training program, you must have obtained the required level (diploma, required certification or relevant experience), completed a training deemed equivalent.

### DOCUMENTS TO BE SUPPLIED

1. A stamped handwritten application
2. Copy of birth certificate or legal equivalent
3. Certified Photocopy of diplomas (or certificates) obtained and CV
4. Two (2) most recent passport photos

**CONDITIONAL ADMISSION:** It is understood that a prerequisite needs to be completed or strengthened in order to undertake MBA studies.

Appropriate methods, in view of the background or previous experience, may be adopted for the assessment. In this case, the conditions of acceptance will be clearly stated in the response to the candidate.

### **PROGRAM CHANGE:**

An admitted student, who is already enrolled and wishes to change their training program, must submit a program change request and attach the receipt justifying payment made towards the assessment of their case. He / she must therefore meet the conditions for admission to the new program.

### **TUITION FEES: The academic fees are fixed as follows::**
